AMENDMENT NUMBER 1

Amendment Number 1 accounts for expansion of the Chapman Select Board from three to five members at its Town Meeting on March 23, 2015. Deletions are highlighted with strikethrough text, additions highlight with bold text.

Section II. Part 1.2. Subpart D. ...the conduct of any business by the Joint Board shall be ~~eight~~ **(9)** members, regardless of member town affiliation.

Section II. Part 1.3. Each of the ~~13~~ **15** Joint Board members shall have a weighted vote...

Section III. Part 2.4. Each of the ~~13~~ **15** Joint Board members shall have a weighted vote...

Section V. Part 3.1. The Municipality of Chapman shall have ~~three~~ **(3)** ~~five~~ **(5)** Directors.

Attachments 3 through 5. Replaced in whole to reflect five voting members.

This Amendment is hereby incorporated into the Interlocal Agreement dated September 9, 2009 and shall be effective March 24, 2015.
